She volunteered for the Foster Care Citizen Review Board for several years. She would review Foster Care cases and make recommendations to the Judge about the plan for the children. She worked in the insurance field and for Kennecott while the smokestack was being built. She worked for Fleming Foods in the accounting department. She

also helped raise her grandchildren, which she enjoyed very much.
