



## Hal Roger Cannon

*October 15, 1935 ~ April 28, 2022*

Retired Financial President, Investment Banker and Business Owner, Hal Roger Cannon spent the last days of his life surrounded by his loving Family. He passed away on April 28, 2022.

He was born October 15, 1935, to Shirl Duke and Dessa Ann Meikle Cannon in Salt Lake City, Utah. Hal grew up loving sports. As a young man he played golf and even caddied for a time. He was always happiest with his family at their cabin in Teton Valley Idaho surrounded by his children and grandchildren.
