Born on November 24, 1946, to Leland Rafell Dickey and Mary June Allphin in American Fork, Utah, John began this life's adventure as the second eldest of eight children. John had a love of the gospel, his country, and family. He loved his brothers and sisters, children, and grandchildren with his whole heart.

Serving a two-year mission in Calgary, Canada for the Church of Jesus Christ of Latter-Day Saints, John found a passion for the gospel, sharing his experiences and love of the pioneers and our Savior. He held many callings including working in the temples where he felt peace and joy. John loved our country; enlisting in the army shortly after his mission, he was stationed at Fort Belvoir in Virginia, serving some of his time in Korea.

John and Sherrie spent a lot of their time taking people on Trek to Martin's cove and feeling the spirit of those that came before us.

John was a man of many trades, gaining experience on oil rigs, welding, construction, and so much more. He loved building and fixing things and could operate nearly any tool in the construction industry. He was always proud of the work he did and loved sharing it with those around him.
