Shirley Ann was an active and devoted member of The Church of Jesus Christ of Latter-Day Saints, serving in various positions. She was the President of the Relief Society, a Gospel Doctrine Teacher, and held many other important roles.

She loved College Basketball, especially the NCAA men's basketball playoff time.

She is preceded in death by her husband, Reece Goodrich, and her daughter, Claudia Ruth Goodrich Stevens.
